1. INTRODUCTIONS / AGENDA REVIEW

2. COMMITTEE BUSINESS

- **Meeting Summary of 9.14.21**
- **MIC Director's Report**
 - The MIC's 2019 [I-35 Bayfront Traffic Modeling Study](#) has again received accolades from the Institute of Transportation Engineers (ITE). In September the ITE Great Lakes District presented the MIC and study consultant Alliant Engineering its 2021 Transportation Achievement Award in the *Transportation Systems Management and Operations (TSMO)* category.

Described as “a challenging project with unique and innovative solutions,” thirty strategies were developed to improve traffic flow, parking operations and wayfinding in the Bayfront/DECC area during special events. Extensive stakeholder participation, traffic modeling, and the use of a short-term pilot study to test proposed solutions were cited as notable elements of the planning process.

This is the second time this study has received formal recognition by the ITE. In 2019 the North Central District presented its Transportation Achievement Award to the Bayfront project for excellence in the advancement of transportation.

- The MIC provided two letters of support during September. The first was in support of the DTA's pursuit of the “Areas of Persistent Poverty” FTA grant for their “DTA Bus Rapid Transit Feasibility and Corridor Study” project. The second was in support of the University of Minnesota Duluth's Bureau of Business and Economic Research proposal to conduct an economic assessment of the conversion of Duluth's current freeway system to a single parkway system, as proposed by the Duluth Waterfront Collective. Converting the current freeway system to a parkway would create space for 20 acres of developable land and could stimulate one of the largest developments in Duluth's history.

OPPORTUNITY FOR PUBLIC COMMENT

3. GUEST SPEAKER: CENTRAL ENTRANCE CORRIDOR PLAN; AUSTIN HAUF, WSB

MnDOT has scheduled a full reconstruction of Central Entrance from Mesaba Avenue to Trinity Road in 2026. The Central Entrance Transportation Plan will set the vision and provide direction for MnDOT's upcoming preliminary design and public involvement/engagement processes by advancing the vision of a walkable, bikeable, transit-oriented urban thoroughfare that (1) is safe and comfortable to use by both motorized and non-motorized users and (2) encourages new types of residential and commercial development. This plan will consider and incorporate the numerous past plans along this key regional corridor. The MIC has hired WSB as its consultant to conduct a Central Entrance Transportation Plan, which is to be completed by the end of 2021.

Virtual weekly meetings between MIC staff and WSB continue. The seventh Steering Committee meeting of key partners has been held. A broader Community Advisory Committee of a wide diversity of corridor stakeholders has met twice. Several public engagement events have been held. The plan’s logo/branding and an interactive website was established and has been live for several months. WSB staff will present an update on all of this work, and summarize the ideas for completing this plan later this year.

4. ADOPTING THE 2022 WISDOT PUBLIC SAFETY PERFORMANCE MEASURES

Wisconsin Department of Transportation (WisDOT) established statewide calendar year 2021 performance targets for each of the five HSIP performance measures in accordance with 23 CFR 490.209. Duluth-Superior Metropolitan Interstate Council agrees to plan and program projects so that the projects contribute to the accomplishment of WisDOT’s calendar year 2022 HSIP targets for:

7. 2021 UPDATE OF THE PUBLIC INVOLVEMENT, TITLE VI & LIMITED ENGLISH PROFICIENCY PLANS

The MIC’s Public Involvement Plan (PIP), which identifies steps and strategies for public engagement at each phase of the planning process, was last updated in 2018. The PIP again requires a full review and update by the end of this year to ensure compliance with the federal FAST Act. With this update we include information about virtual and “hybrid” meetings, and a key goal is to identify and solidify our relationships with key constituencies.

Because our Public Involvement Plan itself needs public involvement, the [draft PIP](#) is now available for the mandatory 45-day comment period through November 30. I invite and encourage you to take a look and get back to me with any feedback or comments you may have (rwatson@ardc.org).

Our Title VI and Language Access Plans are also being updated. They similarly focus on identifying and reaching out to traditionally underserved communities. I will present information about all three plans at the October meetings, prior to presenting them for Board approval in December.

- FY 2026 Duluth Area TIP Projects**

The development of the 2023-2026 Duluth Area TIP kicked off with a pre-application meeting on September 30, with the jurisdictions eligible for federal transportation funding in attendance to discuss FY 2026 candidate projects. The new project selection process is based on group discussion to vet projects and decide which projects will move forward via consensus decision making. Project applications will be available in January 2022, due in February, reviewed by the TAC and MIC Policy Board for approval in March. The draft TIP is scheduled to be released in June with final approval scheduled for August. Also, note that Transportation Alternatives (TA) and Safe Routes to School (SRTS) grants are available.
