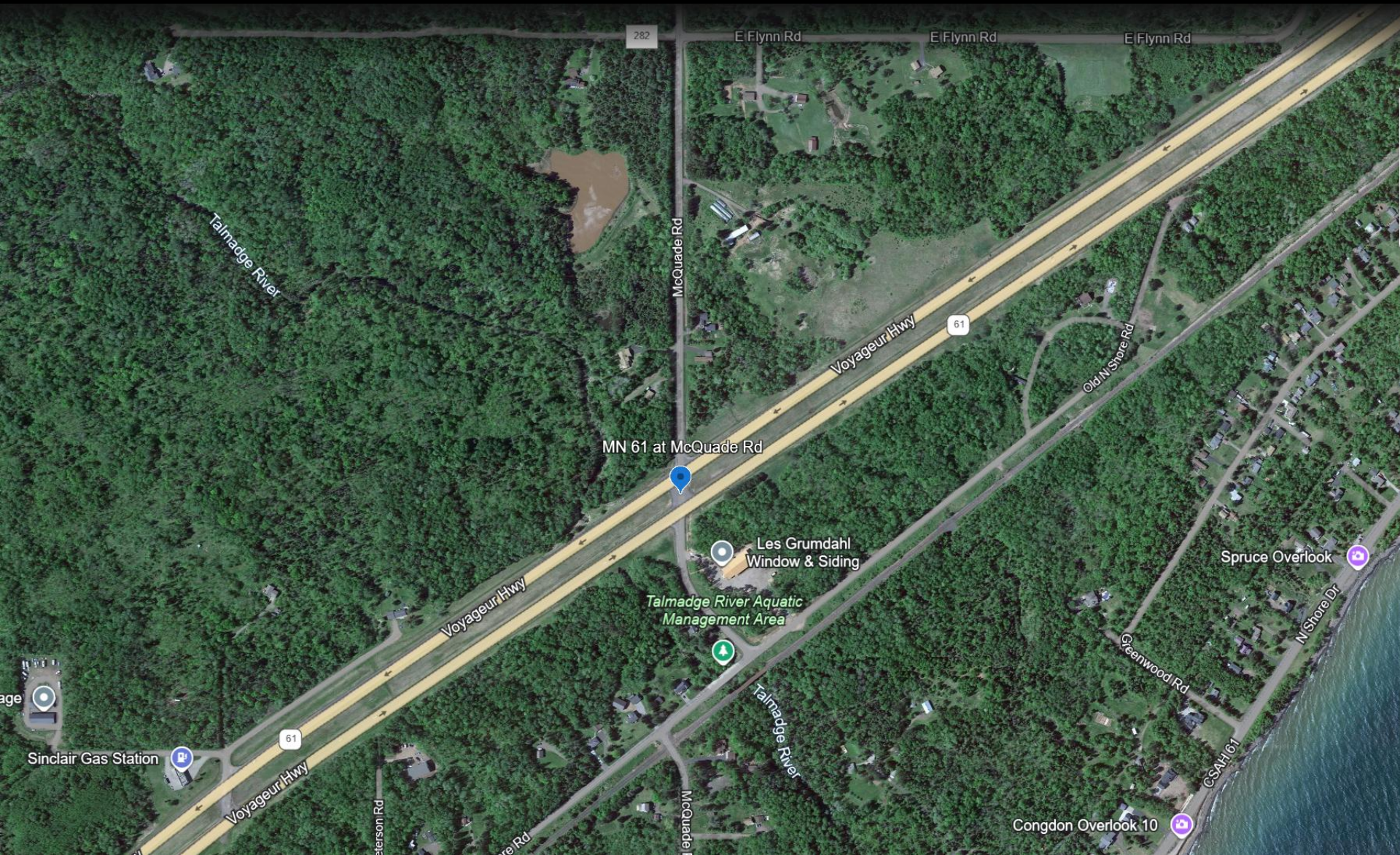

2025-2028 Duluth Area TIP Requested Amendment #2

Requested changes to a single 2026 construction project (MN 61 at Jct of McQuade Rd)

- **MnDOT lead and St. Louis County assisting**
- **Separated into three state project ID's**
 - **069-070-074 – Project Scope Change**
 - **6926-58 – Project Scope Change**
 - **6926-58N – Project Scope, Type of Work, and Cost Change**

Requested Amendment #2

Change Project Scope for 069-070-074 (FY 2026)

- Project Scope Change – St. Louis County is requesting removal of “Talmadge River Culvert Repair and Install RWIS” from the scope.
- RWIS (Road and Weather Information System) is now MnDOT only.
- No cost changes.

2025-2028 Duluth Area TIP Requested Amendment #2

Change to Project Scope for 6926-58/58N (FY 2026)

- Project Scope Change – MnDOT is requesting removal of “Talmadge River Culvert Repair” from the scope.
- RWIS (Road and Weather Information System) was not removed from these projects.
- No cost changes.

2025-2028 Duluth Area TIP Requested Amendment #2

Change to Type of Work and Cost decrease for 6926-58N (FY 2026)

Type of work change – MnDOT is requesting type of work change from “Drainage” to “Pavement Resurface and Rehabilitation”, with a related cost decrease;

- \$1,000,000 decreased to \$188,890 Total Project Cost
 - \$800,000 decreased to \$153,794 Federal Funds
 - \$200,000 decreased to \$35,096 State Match
