# **2025-2028 Duluth Area TIP Amendment #6**

**City of Duluth has requested a cost increase, scope change and description correction for the Railroad St Project from Canal Park Dr to 5<sup>th</sup> Ave W (2025) (#118-118-005)**

- Cost increase is due to updated project estimate.
- Total project cost increase from \$2,100,000 to \$2,500,000 for a total cost increase of \$400,000
- Storm Sewer work has been removed from the project.
- Correction to project description to include replacement of traffic signals and streetlights.
